REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000 Ref No: FOI2019/00681

I write in connection with your request for information received on 29th January. I note you seek access to the following information:

Dog Theft

What were the total number of dog theft crimes in 2016, 2017 and 2018?

What was the outcome (charge/summons, community resolution, active investigation, evidential difficulties, no suspect identified) for each dog theft crime in 2016, 2017 and 2018?

Does your force have a dedicated team or team member who is responsible for overseeing such reports?

What criteria do you use for recording a dog/puppy as a theft as opposed to missing?

I am required by the Freedom of Information Act 2000 (The Act) to handle all requests in a manner that is blind to the identity of the requestor. Any information released in response to a request is regarded as being published and therefore, in the public domain without caveat.

Following enquiries within the Force please see our response below.

Response - Bedfordshire Police made a significant investment in a new ICT system, Athena, in May of this year which, when fully implemented, will help keep Bedfordshire safe, bring more offenders to justice and improve outcomes for victims. Updating our ICT was absolutely necessary to ensure Bedfordshire Police remains as effective and efficient as possible. The public should be reassured crime continues to be reported and investigated as normal but whilst colleagues become more comfortable and familiar with how Athena works Bedfordshire Police has some concerns around data quality for which reason some of the data provided concerning events recorded after 23 May, may include some inaccuracies. We apologise for the situation and are working to resolve it as soon as possible.
