REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000 Ref No: FOI2019/00682

I write in connection with your request for information received on 29th January. I note you seek access to the following information:

Sheep FOI

1. How many crimes of theft* involving sheep have been recorded over the last calendar year (annual year, Jan-Jan)?
2. What were the recorded outcomes/disposals of each of the crimes of theft involving sheep over the calendar year: 2018 (annual year, Jan-Jan)?
 - a) If possible, can you tell me how many of these crimes were referred to the CPS?
3. What was the total number of sheep stolen over 2018 where recorded (annual year, Jan-Jan)?

*Crimes of theft meaning the number of crimes reported, not individual numbers of sheep.

I am required by the Freedom of Information Act 2000 (The Act) to handle all requests in a manner that is blind to the identity of the requestor. Any information released in response to a request is regarded as being published and therefore, in the public domain without caveat.

Following enquiries within the Force please see our response below.

Response - Bedfordshire Police made a significant investment in a new ICT system, Athena, in May of this year which, when fully implemented, will help keep Bedfordshire safe, bring more offenders to justice and improve outcomes for victims. Updating our ICT was absolutely necessary to ensure Bedfordshire Police remains as effective and efficient as possible. The public should be reassured crime continues to be reported and investigated as normal but whilst colleagues become more comfortable and familiar with how Athena works Bedfordshire Police has some concerns around data quality for which reason some of the data provided concerning events recorded after 23 May, may include some inaccuracies. We apologise for the situation and are working to resolve it as soon as possible.
