I write in connection with your request for information received on 17th June. I note you seek access to the following information:

**Under 18 drug dealing**

**How many under 18s have been arrested in the past four years (2015-2018) for the supply of illegal drugs, or for possession with intent to supply? Please can I have this information broken down per calendar year.**

I am required by the Freedom of Information Act 2000 (The Act) to handle all requests in a manner that is blind to the identity of the requestor. Any information released in response to a request is regarded as being published and therefore, in the public domain without caveat.
