THE OFFENDER THEN ASKED THE IP IF HE WOULD ENGAGE IN A SEXUAL ACTIVITY OVER VIDEO CHAT. THE IP STATES THAT HE DID ENGAGE IN THIS AND THIS WENT ON FOR 5 MINUTES OVER VIDEO CHAT. THE IP STATES THAT THE OFFENDER THEN STOPPED THE VIDEO CHAT AND SENT A MESSAGE SAYING THAT SHE HAD NOW

U/K OFFENDER HAS A VIDEO OF THE IP MASTURBATING AND IS THREATENING TO SHOW FRIENDS UNLESS THE IP GIVES THEM MONEY

THE OFFENCE HAS TAKEN PLACE BY VIA FACEBOOK. THE OFFENDER HAS ASKED THE IP TO VIDEO CHAT. THE IP HAS AGREED TO VIDEO CHAT, AND WHEN ASKED HE HAS GOT NAKED. ONCE THE CALL HAS ENDED THE PROFILE HAS SENT HIM MESSAGES, THREATENING HIM THAT IF HE DOESN'T PAY Â£2,000 THE OFFENDER WILL SHARE THE VIDEO. THE OFFENDER HAS STATED THAT IF THE IP DOESN'T PAY UP THE OFFENDER

ON THE STATED DATE AND TIME THE IP WAS CONTACTED BY AN UNKNOWN OFFENDER. THE IP AND UNKNOWN OFFENDER EXCHANGED MULTIPLE MESSAGES ON SOCIAL MEDIA (FACEBOOK), THE IP VIDEO CALLED THE UNKNOWN OFFENDER ON FACEBOOK AND THE IP PERFORMED ACTS OF A SEXUAL NATURE DURING THIS VIDEO CALL. THE UNKNOWN OFFENDER THEN INSTANTLY SENT THE IP A VIDEO OF THE EVENTS THAT HAD JUST HAPPENED, ADVISING THAT IF THE IP DOESN'T PAY Â£5000 THAT THIS VIDEO WILL BE SENT TO ALL HIS FRIENDS, FAMILY AND WORK COLLEAGUES. THE UNKNOWN OFFENDER ALSO POSTED THE VIDEO ON THE IP'S PROFILE SAYING THAT THIS IS HOW SERIOUS THEY WERE, HOWEVER THIS WAS DELETED IMMEDIATELY. THE UNKNOWN OFFENDER THEN SENT THE IP A LINK TO AN APPLICATION CALLED "GOOGLE HANGOUTS" SAYING HE NEEDED TO JOIN THIS IMMEDIATELY. THE IP JOINED THE APPLICATION AND WAS CONTACTED BY THE UNKNOWN OFFENDER ON THERE DEMANDING THE MONEY AGAIN. THE IP ADVISED MULTIPLE TIMES HE WAS UNABLE TO AFFORD THIS. BETWEEN THE STATED DATES

AN EMAIL FROM \*\*\*\* STATING THAT THEY HAVE RECORDED THE IP WATCHING PORN AND MASTURBATING AND THEY WILL SHARE THE VIDEO IF THEY DO NOT SEND ER \$2900 DOLLARS VIA BIT COIN. THE IP DOES NOT TAKE THIS TOO SERIOUS AS SHE HAS NOT BEEN WATCHING ANY PORN ON HER COMPUTER. THE IP HES BEEN

UNKNOWN OFFENDER HAS EMAILED THE IP STATING IF SHE DOES NOT PAY THE OFFENDER 3,150 IN BIT COINS A SEX TAPE WITH BE SENT OUT OF THE IP

OFFENDER CLAIMING TO HAVE VIDEO FOOTAGE OF IP WATCHING PORN THAT HE WILL RELEASE IF THE IP DOESN'T PAY HIM \$1000 IN BITCOIN

UNKNOWN OFFENDER HAS TOLD THE IP THEY WILL UPLOAD A VIDEO OF THE IP MASTURBATING IF HE DOES NOT TRANSFER Â£500

THE LOCATION OF THE OFFENCE HAS TAKEN PLACE OVER SOCIAL MEDIA. BETWEEN STATED DATES AND TIMES AN UNKNOWN OFFENDER HAS REQUESTED THAT THE IP ENGAGE IN AN ONLINE VIDEO CHAT. THE IP HAS ACCEPTED. UNKNOWN OFFENDER/S HAVE SENT AN E-MAIL REQUESTING MONEY OR THE OFFENDER/S WILL SHOW IMAGES OF THE IP TO HIS FRIENDS OF HIM USING A PORNOGRAPHIC WEB SITE
THE IP HAS BEEN BLACKMAILED BY A FEMALE OFFENDER ON FACE BOOK VIA THE IP DOING A PRIVATE VIDEO OF HIMSELF AND THEN THE FEMALE OFFENDER THREATENING TO SEND THE VIDEO OUT ON SOCIAL MEDIA
THE VICTIM HAS BEEN SPEAKING TO SOMEONE ON LOVOO THE DATING APP AND THEY HAVE BEEN VIDEO CALLING NAKED AND SEXUALLY. THE VICTIM BELIEVES THE OFFENDER HAS SCREENSHOTTED THE VIDEO AND HAS IMAGES OF HIM NAKED. THE OFFENDER IS BELIEVED TO LIVE IN CAEN IN FRANCE HOWEVER SHE COULD RESIDE ANYWHERE IN THE WORLD. THE IP RECEIVED AN EMAIL FROM INTERPOLE POLICE SAYING THEY HAD RECIEVED A COMPLAINT AND ASKING HIM TO MAKE CONTACT WITH THE OFFENDER, THE IP WAS ALARMED AND BEGAN TO GOOGLE WHAT WAS HAPPENING HIM AND FOUND SIMILAR INCIDENTS ONLINE WHERE PEOPLE HAD ASKED FOR MONEY. THE IP INITIALLY BLOCKED THE OFFENDER HOWEVER THEN REALISED HE HAD REMOVED THE MESSAGES AS PROOF SO HE RE ADDED HER AND ASKED HER ABOUT WHAT HAD HAPPENED SHE SAID IF HE SENT HER 2,000 EUROS THEN SHE WONT POST THE PHOTOS TO HIS FAMILY AND FRIENDS VIA YOU TUBE OR FACEBOOK. THE VICTIM RECEIVED A FRIEND REQUEST FROM A UNKNOWN SUSPECT ON INSTAGRAM. THE VICTIM ADDED THE SUSPECT AND THEN BOTH CHATTED TO EACH OTHER ON SKYPE WHERE THEY BOTH MASTURBATED. THE VICTIM THEN RECEIVES A MESSAGE ON FACEBOOK STATING THAT THEY HAVE A RECORDING OF THE VICTIM
IP STATES THAT SOMEONE HAS TAKEN A VIDEO OF HIM GETTING NAKED VIA HIS SKYPE AND IS NOW ASKING FOR Â£900 OR THEY WILL RELEASE THE VIDEO. THE IP KNOWS THEY HAVE THE VIDEO AS THEY HAVE ALREADY SENT IT TO HIS GIRLFRIEND. THEY MANAGED TO ALSO GET PASSWORDS TO THE IP'S INSTAGRAM AND FACEBOOK ACCOUNTS ASWELL AS CONTACTING HIM ON WHATSAPP.
THE LOCATION OF THE OFFENCE IS A VIA SOCIAL MEDIA. BETWEEN STATED DATES AND TIMES THE IP HAS MET THE OFFENDER ON TINDER. THE IP AND OFFENDER HAVE CHATTED BEFORE PROGRESSING TO A SKYPE VIDEO CHAT IN WHICH THE CHAT BECAME INTIMATE AND THE IP HAS EXPOSED HIMSELF. THE CONVERSATION BEGAN TODAY AT 10:31 WITH SOMEONE INTRODUCING THEMSELVES AS THE IP AND THE OFFENDER INTRODUCING HERSELF. THE CONVERSATION CONTINUES THROUGHOUT THE DAY UNTIL 17:25 WHERE THE OFFENDER BEGINS TO BLACKMAIL THE IP. THE OFFENDER VIDEO CALLS THE IP DEMANDING Â£600 TODAY AND Â£3000 OVER THE NEXT FEW DAYS. THE IP SAW THE OFFENDER'S FACE AND STATES SHE SPOKE ENGLISH AND DID NOT HAVE AN ACCENT. THE OFFENDER SAID SHE WAS FROM FRANCE AND WANTED HIM TO SEND A POSTAL ORDER TO 00225. THE OFFENDER HAS THEN MESSAGED THE IP (FROM \*\*\*\* ) ASKING FOR MONEY OR THEY WOULD DISTRIBUTE THE VIDEO TO HIS

ON THE EVENING OF \*\*\*\* BETWEEN 21:00- 23:00 THE IP HAS STARTED RECEIVING FACEBOOK MESSENGER MESSAGES FROM '\*\*\*\*'. THE MESSAGES STARTED OUT AS CONVERSATIONAL AND PROGRESSED TO THEM SUGGESTING THE IP ENGAGE IN SOME SEXUAL BEHAVIOURS WITH THEM OVER VIDEO CHAT. THE IP HAS MASTURBATED WHILST WATCHING THE FEMALE HE WAS TALKING TO MASTURBATE. LATER ON IN THE EVENING SHORTLY AFTER THE CONVERSATION HE BEGUN RECEIVING MESSAGES REQUESTING FUNDS FROM HIM OTHERWISE THEY WOULD SHARE THE IMAGES/VIDEOS OF THE IP MASTURBATING TO YOUTUBE AND

BETWEEN STATED DATE AND TIMES THE VICTIM HAS BEEN SENT A FRIEND REQUEST VIA FACEBOOK BY THE NAME OF '\*\*\*\*' AND THEY HAVE STARTED TO TALK VIA FACEBOOK MESSENGER. THE UNKNOWN OFFENDER/S WHO ARE USING SAID ACCOUNT HAS THEN SENT THE VICTIM AN INTIMATE VIDEO OF HIMSELF THAT THE VICTIM HAS USED. THE OFFENDER/S HAVE THEN ASKED FOR Â£3500 FOR AN ORGANISATION FOR ILL CHILDREN AND THEN THEY WOULD DELETE THE VIDEO AND IMAGES TAKEN FROM THE VIDEO. DUE TO THE FACT THE VICTIM DID NOT HAVE Â£3500 HE HAS OFFERED THEM Â£150 WHICH THEY HAVE AGREED TO

THE LOCATION OF THE OFFENCE IS VIA FACEBOOK AND WHATSAPP. BETWEEN STATED DATES AND TIMES UNKNOWN OFFENDER(S) HAVE ADDED THE IP ON FACEBOOK AND HAD A CONVERSATION WITH SOMEONE. THE IP HAS THEN ADDED THE OFFENDER ON WHATSAPP AND HAD A VIDEO CONVERSATION WITH A WOMAN, IN WHICH THEY BOTH WERE NAKED AND SHOWING GENITALS. AFTER THE CONVERSATION THE IP WAS CONTACTED ON ANOTHER NUMBER STATING THAT UNLESS HE PAID \$5000USD, PICTURES OF THE IP
